**DESTINATION** → Plasters, walls, artifacts and metal surfaces. Do not apply on sensitive or not solvent resistant substrates.

**PROPERTIES** → **SUPERREMOVER** is the **super-fast gel product for all wall surfaces**. The product contains a mixture of particular solvents which **act selectively on tenacious, stratified and aged greasy and synthetic layers**, allowing **easy and quick removal**, without altering or damaging the consistency of the substrates.

The removal of the layers is facilitated by the **"exfoliating" action of the product**, allowing its easy and quick removal with a **metal spatula**. The particular gel formulation allows it to be used on facade walls without the product evaporating or dripping onto the ground.

**USE** → Apply the pure product with a brush or a metal spatula, making sure that the surface to be cleaned is dry. Evenly distribute the product over the entire surface affected by the operation, creating a **minimum of product thickness (at least 2 mm)** and letting it act for at least 15-20 minutes. In situations with particularly aged, thick or hardened layers, longer action times or more repeated product passes may be necessary, always following the same operating method described above. Removal of the inconsistent layer can then be done **with a simple metal spatula**. Finally, **remove the cleaning residues with rags or paper towels** and **rinse thoroughly with pressurized water**. Wait for the substrate to dry in order to evaluate the effectiveness of the wash. Then uniform the degree of **final cleaning** by using the detergent appropriate to the nature of the support. Establish the right application method through preliminary tests, in order to avoid possible side effects.

**YIELD** → As an indicative purpose **5-10 m<sup>2</sup>/lt** of product.

It must allow the rapid elimination of all types of fatty or synthetic layers present on the surfaces for which it is intended without altering its appearance and consistency. It must be accompanied by a 16-section safety sheet as required by current legislation.

- Product intended for professional use.
